
The official languages of the conference will be Greek and English. Professional interpreters will be on hand throughout the three-day event to facilitate communication.



The Future of Hellenic *Paedeia* in a Democratic Society: The Catalyst for the New Upcoming Intellectual Renaissance for the World (again!)

Photo 1 below is a triangular representation where three key Hellenic words, Person (*polites*), Ecology (*oikologia*) and Economy (*oikonomia*) are at the apexes of the triangle. They form the basis for a balanced education, where the needs of the individual (the citizen, if you will), the logic for the environment that sustains *anthropos* and the laws of nature and society {that support and limit our activities for having a vibrant and sustainable (α ειφόρος) economy} in order to make a living.

Our institutions are operating within the area of the three key apexes of the triangle and are fed by the key democratic (Hellenic) values which are also inside the triangle. As such, these values constantly fertilize the educational process, thus producing a sustainable ($\alpha \epsilon \iota \phi \delta \rho o \varsigma$) ecumenical product of *paedeia* for the needs of the 21st century and indeed the third millennium. Thus, Hellenic *Paedeia* is not only the past but, indeed, the future for all humanity. It has to be, if there are no longer economic borders for the nations of the world. Please study this chart and arrive at your own conclusions. If you believe in democratic values, and especially if you are an AHEPAN, you will recognize the Hellenic values for a democratic society; if you are a philosopher, social scientist/sociologist, or anthropologist, you will recognize the anthropocentric view that *anthropos* (person) is the central theme and without him, civilization is immaterial; if you are an economist or any professional, you will see your place and if you are an environmentalist, you know you can not ignore the issues that impact on the environment. What else is there?


Photo 1 - The Future of Hellenic Paedeia

Photo 2 further defines key elements of Hellenic *paedeia* in terms of 12 Hellenic words or concepts which have defined both ancient Hellenic education and modern western thought since the renaissance times. Credit is given here to Rev. Dr. Demetrios Constantelos who discussed the 12 words in his Hellenic Heritage booklet a few years ago. It is this kind of education which will produce an integrated and balanced person with character. A character that will have the Hellenic measure avoiding extremes and fanaticism, who will have both technical and human skills with which to make a living and also live well ($\tau o \varepsilon u \zeta \eta v$ or the pursuit of real happiness), and be more suitable and flexible for a globalized or ecumenical world. Again, Hellenic *Paedeia* may have more of a future than past. At least, it appears that way, if there is to be a future for our world, Greek or not. Conclusion

An individual trained in the above manner is much more likely to be (1) a balanced person not only how to make a living, but also how to live well; (2) a person with character and skills capability/potential; (3) a person having the $\varepsilon v \zeta \eta v$ philosophy for the pursuit of happiness; (4) an individual that uses $\mu \dot{\varepsilon} \tau \rho v /$ measure to moderate and avoid extremes and (5) be a member of a society with ecumenical education ready for Globalization without any economic national borders!

WEBMASTER'S REPORT Dr. Ulysses J. Balis



The ongoing process of the AFGLC Website modernization is well under way, with a number of infrastructure enhancements to the web server layer already being complete. With the recent demonstration of the newly-gained search capability, at the 2008 Forum, continued efforts are being taken to add to this search capability (provided by Google) an automatically-updated site map. Besides assisting visitors of the website, the site map will assist automated search engines in their carrying out of a deep search of our content, ensuring that all of our information is available. Towards the goal of having as much content as possible being available on the website, we are nearly finished with a long-term project to revise the archives section. This new resources has two notable features: 1) it also allows for real-time deep searching via the Google functionality and 2) each resource is managed by a fully functional Wiki cover page, such that annotation and content update can be carried in real time out by interested membership.

In addition to the Archive-associated Wiki, the Website will be equipped with a second, stand-alone Wiki, to be used for all official activities of the Foundation, including education, meeting planning and organization, and information exchange between members and foundation committees.

Finally, upon approval of the Executive Committee, Webbased online donation and registration will be activated, completing the set of enhancements that were announced last year. It is hoped that this feature sill simplify the process of charitable giving to the Foundation. in Interdisciplinary Curricula" by Dr. James Strange.

The second session, "The Impact of Hellenic Thought in the Creation of American Democracy," was moderated by Dr. Christos Evangeliou, Professor of Philosophy, Towson University, Towson, MD. After introductory remarks by Dr. Evangeliou, Dr. Michael T. Gibbons, Associate Professor of Government and International Affairs, USF, read his paper on "Greek Philosophy and the Founding of America;" there followed a general discussion, replete with insightful comments and remarks by the audience.

The third session, "Vignettes from Hellenic Diaspora through the Ages," consisted of contributions by Mr. John Krinos ("Syros, a Cultural Beacon in the 19th Century"), Dr. Marios Stephanides, Professor of Sociology, University of Tampa ("Hellenic Diaspora: The Greek-American Experience"), and Dr. Bill Manikas, Professor of History, St. Petersburg College, St. Petersburg, FL ("Historical Vignettes from Tampa").

Closing the activities of the first day was a panel discussion on "AFGLC: Work in Progress and Plans for the Future," moderated by Dr. William Yotis, Professor *Emeritus*, Loyola University, and Clinical Professor of Microbiology and Immunology, USF. Contributors were Dr. Peter Yiannos, President of AFGLC, Tri-State Center, Wilmington, DE; Ms. Kalliope Halkias, MPH, President of AFGLC Tampa Bay Center; Dr. Byron Palls, VP and Editor, AFGLC/IFGLC; Mrs. Ourania Stephanides, Secretary of AFGLC/IFGLC, Tampa; and Dr. Ulysses Balis, Associate Professor of Pathology, Director of Clinical Informatics, University of Michigan, Ann Arbor, and AFGLC Webmaster.

The emotional highlight of the Conference was a special dinner/reception, held on the evening of March 7 at the Embassy Suites Hotel, for the purpose of honoring two outstanding Hellenes, Dr. John Anton and Dr. Demetrios Constantelos. Dr. Anton, Distinguished Professor of Greek Philosophy and Culture at the University of South Florida, and Dr. Constantelos, Distinguished Professor Emeritus of the Richard Stockton College of New Jersey, were presented special citations by Dr. John Balis, President of AFGLC/ IFGLC, in recognition of their life-long contributions in the service of Hellenism. The elegant and thought-provoking keynote address by Dr. Anton was received most enthusiastically by the audience (copies will be made available upon request from <u>bpalls@verizon.net</u>). The reception was very well attended by the AFGLC membership and by officials of the University of South Florida and of AFGLC/IFGLC Headquarters.

The second day's activities were led by Dr. Tom Papademetriou, Executive Director of ICHS, Stockton College, NJ, who moderated the first session, "Educational Commitment to Principles of Hellenic Paedeia." Contributors were Dr. Christos Evangeliou, Professor of Philosophy, Towson University Paedeia: Education for Leadership," Dr. Lucio Angelo Privitello of the Philosophy and Religion Department, Stockton College, NJ, whose paper was titled "Education and the Art of Teaching: The Apprenticeship in Ideals in Plato's



Socrates," and Dr. Michael Funke of the University of South Florida, who concluded the session with "Aristotle's Account of Akrasia and its Contemporary Incarnations."

The second session, "Hellenism and Language/Culture," was moderated by Dr. Maria Esformes, Associate Professor of World Language Education, USF. Delivering papers were Mr. Theodoros Katerinakis, PhD candidate, Department of Culture and Communication, Drexel University, Philadel-phia, PA, "The Universal Hellenic Mother Tongue: Zolotas' Unified Speeches as a Global Logion;" Dr. Eka Tchkoidze, Post Doctoral Fellow, Program of Hellenic Studies, Prince-ton University, NJ, "Greek Words and Male Names in the Georgian Life of George the Athonite (XI Century);" and Dr. Maria Hranaki, Director of Greek Studies, Drexel University, Philadelphia, PA, "Bridging Arta with Beijing: The Master Builders Kazantzakis and Kalomiris."

The third and final session, "Hellenism and Sciences," was moderated by Dr. Elias Stefanakos, Professor and Director, Clean Energy Research Center, College of Engineering, USF. Mr. Philip Kaplan, a graduate student of the University of North Florida, Jacksonville, FL. read his paper on "Early Greek Accounts of Travel Exploration;" and Dr. Ulysses Balis reviewed and amplified the information presented at last year's Forum on this fascinating computer-like device of the 1st Century BC with his "Update on the Anti-kythera Mechanism."

The Forum/Conference was brought to a conclusion with a lengthy discussion on the effectiveness of our Interdisciplinary Centers and on the current and ideal relationship between them and AFGLC/IFGLC ("ICHS: Issues and Prospects"); the discussion was moderated by Dr. Karen Weidenheim, Professor of Pathology, Albert Einstein College of Medicine, Chief, Division of Neuropathology, and Director, Neuropathology, Residency Program, Bronx, NY.

Dr. Balis and Dr. Strange made congratulatory remarks on the success of this, the 13th Annual AFGLC Forum/ Conference, and concluded by urging all those in attendance to evaluate the two day event.

DR. JOHN ANTON

Dr. John Anton, the distinguished Professor of Philosophy and Director of the Center for Greek Studies at USF, holds a Doctorate degree from Columbia University (he wrote his dissertation on Aristotle).

He has published 30 books (his latest: American naturalism and Greek Philosophy, 2005) and over 200 articles. He is an Honorary Citizen of Samos for his contributions to the study of Ionian Philosophy, and holds doctorates Honoris Causa from the Universities of Athens, Patras and Ioannina. He is a Corresponding Member of the Athens Academy. He contributes large amounts of his time to professional organizations, as President of the Georgia Philosophical Assn., President of the Society for Ancient Greek Philosophy, Board member of the Society for the Advancement of American Philosophy, President of the International Society for Neoplatonic Studies, and Honorary President of the International Society for Greek Philosophy. He is listed in Who is Who in America, Who is Who in the World, The Directory of American Scholars, Contemporary Authors, and Leaders in Education.

He played a seminal role and put forth a strong effort to help create AFGLC and give it structure

Dr. Anton is the epitome of the scholar who has made it his life's purpose to serve Hellenism and who continues to articulate so powerfully the Hellenic Spirit to which he has dedicated his life.

THE REV. DR. DEMETRIOS CONSTANTELOS



The Rev. Dr. Demetrios Constantelos, the "Charles Cooper" Townsend Distinguished Professor *Emeritus* of History and Religion, and Research Scholar at the Richard Stockton College of New Jersey, holds a Doctorate from Harvard (his dissertation, *Byzantine philanthropy and social welfare*) has become the standard reference work in this area. He began his teaching career at Holy Cross in Brookline, MA and ended it at the Stockton College, only to be named *Distinguished Research Scholar in Residence*.

In tandem with his academic career, he has served various Hellenic communities as pastor (St. Demetrios, Perth Amboy, NJ, St. Nicholas, Lexington, MA) and helped establish three communities in South New Jersey (St. Barbara in Toms River, St. Anthony in Vineland, and Holy Trinity in Egg Harbor Township).

He is a recognized authority on Byzantium and the Byzantine world, and has published numerous books and articles on topics ranging from the Greek religious identity and the Orthodox Liturgy, to Philanthropy and other aspects of the Byzantine Empire as a reflection or continuation of our Classical Greek heritage.

Prof. Constantelos has dedicated his entire life to the Hellenes of the diaspora as their spiritual leader and to the academic world of his adoptive country as a courier of the torch of Hellenism, educating generations of students about the beauty of the Hellenic Spirit and its continued presence in our lives.



MR. ANGELOS LANGADAS: AN AFGLC BENEFACTOR



As a young man, Mr. Langadas served in the Air Force of his native Greece before going to sea as an Engineering Officer on Greek and US vessels during WWII (1939-45). Soon after, it was the US Army's turn to draft him and send him to Korea. Once a civilian again, he put his valuable knowledge to work as Superintendent Marine Engineer for Southern Star Shipping Co. in New York, where, among other duties, he supervised the construction of some 20 freighters and tankers in Japan and Spain. Following his retirement, he settled in Boca Raton, Florida where he has been active in a host of projects for the benefit of the community. A special moment in Mr. Langadas' life came in 1996, when he was chosen to carry, ever so proudly, the Olympic torch through the city of Boca Raton.

This Hellenic gentle man has worked quietly to establish scholarships for students of Greek heritage at: the Florida Atlantic University, the University of Florida, the University of Arizona, AHEPA chapter #487 of Boca Raton, and District II of AHEPA. He has also supported financially several other organizations, among them our own AFGLC, to which he has donated \$100,000 to sponsor one of the professorships of the ICHS at USF. This summer, the *Langadas Professorship of Greek Culture* will become a reality, a perpetual reminder of the generosity of a great Hellene who, equally proudly, has helped professors pass the torch of the Hellenic Spirit to future generations. He has found enormously rewarding his acts of Philanthropy and writes: "Giving gifts to help others in need, that is what is called happiness." 
ANNOUNCING A LECTURE SERIES TO HONOR THE MEMORY OF DR. DEMETRIOS HALKIAS

INTERDISCIPLINARY CENTERS FOR HELLENIC STUDI What They Are and How They Function



An Interdisciplinary Center for Hellenic Studies (ICHS) is what our Foundation aims to create in institutions of higher learning. First, AFGLC seeks to establish AFGLC chapters in areas that have a sizeable Hellenic population as well as colleges or universities. The chapter identifies receptive Hellenes or philhellenes who are willing to sponsor professorships at the local university. AFGLC then approaches the university and expresses an interest in forming a partnership for the purpose of supporting one or more professorships in Hellenic Studies. Upon acceptance, the university and AFGLC/IFGLC contract to establish an ICHS under the control of



the university, which appoints a Director to over see its affairs. A Board of Directors presides over the ICHS-which includes officers of AFGLC/IFGLC as members *ex officio*. Typically, an ICHS consists of professorships five areas of study: Greek Language & Literature, Greek History, Greek Philosophy, Byzantine History/Orthodox Religion, and Greek Culture. The students of the university, regardless of major, may pursue work in any one of these areas not only for personal edification, but also for their relevance to their field of study. The donors support our mission objectives because they believe strongly in providing today's students with the fundamentals of Hellenic education, critical to shaping the thinking of tomorrow's leaders. Conversely, they are hoping to see their own children and grand children take advantage of such offerings in order to be proud of their Hellenic heritage, and understand why Greece has been called the "Cradle of Western Civilization" and the Hellenic spirit the "Patrimony of the World."

The interest derived from the donated funds is used for the professorships of the ICHS. The professorships are so structured that they cannot be terminated by the university because of budget constraints or changing priorities. This structure guarantees that each endowed professorship will exist in perpetuity—and so will the person who donated the funds for its creation, i.e., the *Langadas Professorship of Greek Culture*.
